T&Cs - Raffles

The Deva Legion, Chester is a H.O.G Chapter sponsored by Chester Harley-Davidson, fundraising for Chapter funds and annual donations to Claire House, Wirral.

Raffle Rules

Thank you for supporting the Deva Legion and Claire House. These terms and conditions refer to all of our raffles.

1. The cost of each ticket entry into any raffle is £1. You may purchase more than one ticket, but the maximum number of tickets is one hundred (£100) per draw. Purchase to enter the raffle must be made before the draw. Any payments received after the draw will be treated as a donation.
2. No tickets can be sold to, on behalf of, or for a person under the age of 18 years. If a ticket is sold unknowingly to, on behalf of, or for a person under the age of 18 they will be exempt from the raffle and will forfeit their prize and the stake will be returned.
3. The raffles are open to all, except those who are directly involved with the raffle draw.
4. The Deva Legion will run an undetermined number of separate raffle draws each year. The draws will take place at least monthly, and as part of the Rally in the Valley.
5. Monies raised by this raffle will support the activities of the Deva Legion, and be accounted for by the Chapter Treasurer.
6. The Deva Legion accepts no responsibility for raffle tickets which are lost, damaged, illegible or from which the prize winner cannot be identified, or for any technical failure or event which may cause the competition to be disrupted or corrupted.
7. A random selection of paper tickets is used to select raffle prize winners.
8. Prizes will be allocated in one of two ways (this will be defined at the point of raffle ticket sale):
 - 8.1. The order of the tickets being drawn from the lowest prize to the highest (i.e. 3rd to 1st).

- 8.2. Self-selection, by raffle winners of prizes on offer.
9. The result of any raffle draw is final.
10. Where the prize winner cannot be identified, the Deva Legion may apply the prize as it sees fit, including re-offering the prize in future raffles.
11. All winners are required to cooperate with the Deva Legion's right to publish their win as and where deemed appropriate.
12. In the event of an error, however caused, whether a printing error or otherwise and whether obvious or otherwise, which affects the competition in any way, the Deva Legion reserves the right to administer the raffle as though the error had not occurred.
13. Failure to comply with any of these rules may result in the disqualification of the entry. The Deva Legion reserves the right to disqualify any entry at their absolute discretion.
14. All raffle monies are held in a dedicated Chapter account.

Appendix One - Dealership Vouchers (Rally 2023)

- Each voucher has a clearly defined 'face value'.
- Vouchers are non-exchangeable and non-transferable.
- Vouchers will be used in full at Chester Harley-Davidson, with no change offered.
- Vouchers can be used against any purchase in store.
- Vouchers can be used as part-payment.
- Only endorsed vouchers will be accepted.
- Voucher expiry date is 31/8/24.

Appendix Two - 2024 Rally Vouchers (Rally 2023)

- Each voucher allows entry to the Rally in the Valley 2024 for 2 people.
- Vouchers have no financial value, should not be re-sold, are not exchangeable and not transferable.
- Vouchers do not entitle the holder to any other additional (paid) services.
- Only endorsed vouchers will be accepted.
- Voucher expiry date is 31/8/24.
